

## **MEDICLINIC PRIME FNB WINES2WHALES EVENT GIVEAWAY**

### **TERMS AND CONDITIONS**

Mediclinic (Pty) Ltd is promoting entries for the FNB Wines2Whales event. Please confirm that you have read, understand, and accept the following terms and conditions of the entry:
