## WORLD'S OLDEST HUSQVARNA ROBOTIC LAWNMOWER COMPETITION ("Competition") Terms and Conditions for Sweden

## 1. THE PROMOTER

The promoter of this Competition is Husqvarna AB (a company registered in Sweden with company number 556000-5331, whose registered office is at 561 82, Huskvarna, Sweden) (**"Promoter**" or **"We"**).

## 2. THE COMPETITION

These are the terms and conditions that will apply to your entry of the Competition. Please read them carefully before you enter the Competition. To be eligible to win a prize, participants must comply with these terms and conditions.

The Competition is open to all residents that are eligible under Section 3 of Austria, Belgium, the Czech Republic, Denmark, Estonia, Finland, France, Germany, Hungary, Latvia, Lithuania, the Netherlands, Norway, Poland, Slovakia, Sweden, Switzerland and the United Kingdom ("**Territory**").

These terms and conditions apply only to participants from the abovementioned countries and their entries upon their acceptance.

To the extent permitted by law, the Promoter reserves the right to hold void, cancel, suspend, or amend the Competition.

## 3. ELIGIBILITY

To be eligible to enter the Competition, you must (i) be a natural person and resident of Austria, Belgium, the Czech Republic, Denmark, Estonia, Finland, France, Germany, Hungary, Latvia, Lithuania, the Netherlands, Norway, Poland, Slovakia, Sweden, Switzerland or the United Kingdom, (ii) aged 18 years or over at the time of entry to the Competition, (iii) who has full legal capacity for legal actions for participation in this Competition under applicable laws, and (iv) who has purchased a Husqvarna robotic lawnmower before the opening date of the Competition (4 February 2025) and (v) continues to own the same Husqvarna robotic lawnmower, (vi) with the exception of the following:

- past and present employees, officers, directors, contractors and agents of the Promoter and their family members or any third party directly associated with the administration of the Competition as well as their respective parents, affiliates, divisions, subsidiaries and successor companies and their family members (and those living in the same household, whether or not related);
- 2. past and present dealers of the Promoter and their immediate and extended family members;
- 3. past and present employees of the Promoter's dealers and their immediate and extended family members; and
- 4. any third party involved at any stage in the development of Husqvarna robotic lawnmowers.

Proof of identity and age may be required.

In entering the Competition, you confirm that you are eligible to do so and eligible to claim any prize you may win. The Promoter may require you to provide proof that you are eligible to enter the Competition and may disqualify you if you are unable to provide such proof on request.

The Promoter may also disqualify any entrant from the Competition who enters the Competition fraudulently or dishonestly including (but not limited to) through the manipulation of codes, multiple computer-generated entries or entries that have been altered, reconstructed, forged or tampered with.

## 4. HOW TO ENTER

The Competition is free to enter.

To enter the Competition you shall submit, via the web form of the landing page:

- 1) your full name and current contact information, including both email address and telephone number;
- the year of purchase of your Husqvarna Robotic Lawnmower (the "Robotic Lawnmower");
- 3) the serial number of the Robotic Lawnmower;
- 4) confirmation that you can and will provide a video clearly showing the Robotic Lawnmower in motion for at least 10 seconds, if requested by the Promoter; and
- 5) an answer to the competition question.

Only the first entry submitted by each participant will be considered. Any additional or multiple entries will not be counted or accepted. Entries made online using methods generated by a script, macro or the use of automated devices will be void. Entries that are incomplete, illegible and/or indecipherable will not be valid and will be deemed void.

The opening date of the Competition is at 08:00 Greenwich Mean Time / 09:00 Central European Time / 10:00 Eastern European Time on 4 February 2025. The closing date of the Competition is at 19:00 British Summer Time / 20:00 Central European Summer Time / 21:00 Eastern European Summer Time on 31 March 2025. Entries received before the opening date and time or after the closing date and time will not be counted or accepted.

## 5. LOST OR DELAYED ENTRIES; LIABILITY

The Promoter accepts no responsibility for entries not successfully completed due to a technical fault of any kind e.g., technical malfunction, computer hardware or software failure, satellite, network or server failure. Proof of delivery of the entry is not proof of receipt.

Insofar as is permitted by law, the Promoter cannot be held responsible for any damage or loss suffered by any entrant entering the Competition or as a result of accepting the prize, unless due to intent or gross negligence on the part of the Promoter.

#### 6. HOW THE WINNERS ARE CHOSEN

Winners will be selected by a Jury consisting of members of the Promoter's Marketing team in Sweden on 4 April 2025. The Jury will review all eligible entries and identify the three owners of the oldest Robotic Lawnmowers that can be in motion for at least 10 seconds, among participants who provided a correct answer to the competition question. The selection process is based purely on objective criteria, namely the correct answer to the competition question and the age of the lawnmower, and there is no subjective element involved.

The participants who provided a correct response to the competition question and are the owners of the three oldest Robotic Lawnmowers within the Territory will win a prize as shown in section 7 below ("**Prizes**").

If all criteria are fulfilled and the Robotic Lawnmowers have the same year of purchase, the Robotic Lawnmowers' serial numbers will be used to determine which Robotic Lawnmower is older based on the date of manufacture.

If there is still a tie relating to any of the Prizes after reviewing the serial number, the winners of the Prizes will be determined based on the time of entry to the Competition – the winner will be a participant who has submitted the entry earlier.

## 7. THE PRIZES

There will be three (3) winners in total in the Territory.

- 1) The winner with the oldest Robotic Lawnmower will receive:
  - a. one (1) Husqvarna Automower® 430X NERA robotic mower with Husqvarna EPOS<sup>™</sup>, including a charging station, with a total value including VAT, as set out in Appendix 1.
- 2) The winner with the second oldest Robotic Lawnmower will receive:
  - a. one (1) Husqvarna Automower® 405XE NERA robotic mower with Husqvarna EPOS<sup>™</sup>, including a charging station, with a total value including VAT, as set out in Appendix 1.
- 3) The winner with the third oldest Robotic Lawnmower will receive:
  - a. one (1) Husqvarna Automower® Aspire<sup>™</sup> R4 robotic lawnmower, including a charging station, with a total value including VAT, as set out in Appendix 1.

A Prize shall not include set up, installation, garden check, tutorials or consumables. If assistance with set up is required, a Husqvarna approved dealer will need to be contacted. This may incur a cost, which the Promoter does not accept responsibility for.

A Prize cannot be exchanged or transferred and no cash alternative is offered.

The Promoter may contact participants to ask for permission to use videos submitted in accordance with section 4. 4) in Husqvarna's marketing and to ask participants whether they would like to participate in Husqvarna's marketing activities.

## 9. THE WINNERS

Winners will be notified by email (using the details they provided on entry) on 4 April 2025 and must provide a postal address to claim their respective Prize. If a winner does not respond to the Promoter within 14 days of being notified by the Promoter, then the winner's Prize will be forfeited and the Promoter will be entitled to select another winner in accordance with the process described in Section 6 above, using the "next oldest" criteria.

## 10. HOW AND WHEN WINNERS WILL RECEIVE THEIR PRIZE

The Prize will be sent to the winners by a home delivery services provider chosen and paid by the Promoter within 60 working days of being notified of their win.

The decision of the Promoter regarding any aspect of the Competition is final and binding. You have a right to complain subject to Section 12 below.

## 11. HOW WE USE PERSONAL DATA

If you choose to enter into this Competition, the Promoter will process your personal data for the purpose of administering the Competition and for the purpose of contacting you regarding participation in Husqvarna's marketing activities, as described in these Terms and Conditions.
